## Dear President Biden:

There is an urgent need for policy action before the end of your Administration's term.

Given the nation's drug overdose crisis, we ask you to immediately lift the current <u>\$75 maximum restriction</u> in certain federal grant programs on patient incentives for recovery behaviors (known as Contingency Management or CM) from opioid, stimulant, and alcohol use disorders. Lifting this cap is crucial for enhancing the effectiveness of treatments for substance use disorders.

In 2022, <u>34,000</u> Americans died from overdoses involving stimulants. Yet, there are no FDA-approved medications for treating Stimulant Use Disorder. Contingency Management has emerged as the standard of care for this disease, according to <u>the leading medical societies</u> in the field of addiction treatment. Unfortunately, access to this treatment is undermined by the existing financial restrictions imposed by SAMHSA and other federal agencies.

The current \$75 cap policy contradicts over six decades of scientific research supporting the efficacy of higher incentives. It also fails to recognize the legality of higher incentive amounts, given an <u>Advisory Opinion</u> from the Department of Health and Human Services Office of Inspector General (HHS-OIG), which allows for up to \$599 per patient per year.

In your Year 1 <u>Drug Policy Priorities</u>, you promised to "Identify and address policy barriers related to contingency management interventions (motivational incentives) for stimulant use disorder." Yet this major policy barrier remains. There is only one month left for the Administration to follow through on this promise.

Given the urgency of the addiction crisis and the strong backing by scientific evidence, we respectfully urge the administration to increase the cap on patient incentives. Lifting this limit would save lives and enhance recovery outcomes across the nation.

We, the undersigned organizations and individual stakeholders, researchers, and advocates for patients and families suffering from this national epidemic, appreciate your attention to this critical issue and look forward to your support in making a necessary adjustment that reflects best practices and scientific guidance.
